Shaping Africa's Instant Payments Landscape

As part of our global positioning, we onboarded 17 fellows from across the world - London, Canada, USA, Europe, Asia etc. Our fellows are seasoned professionals with diverse specialities across the digital finance sector who are supporting the execution of various workstreams on a pro bono basis.

The FinHer Africa series was launched in 2025 as part of our fellowship program in collaboration with an AFN Fellow to celebrate and spotlight women shaping Africa's fintech and digital finance ecosystem. The series shares the journeys, leadership insights, and impact of female innovators, builders, and ecosystem contributors across the continent, highlighting their roles in driving inclusive innovation and ecosystem growth.

2025 was climaxed with our support to a consortium (of AfricaNenda Foundation, Arab Monetary Fund, BTCA, Integal and World Bank) on their seminal work on addressing some of the main challenges facing the uptake of instant payments in Africa, to spur financial inclusion and economic growth.

2026 Strategic Priorities:

AFN's focus will be on expanding our global execution agenda and concurrently advancing our core pan-African programs:

- **Africa Fintech Platform:** The commencement of the actual development of the Africa Fintech Platform- an online digital platform for Africa's fintech community funded by the African Development Bank.
- **Africa Fintech License Passporting:** Commencement of the main building blocks for the actualization of the Fintech License Passporting Scheme- expected to be live by end of 2027.
- **Africa Fintech to the World Series:** Building on the successful inaugural edition in Canada in 2025, the second edition will hold in the second half of this year while we're also working on separate editions with partners in France and the United Kingdom.
- **Africa Fintech Festival 2026-** will be hosted in the Democratic Republic of Congo (DRC) in the second half of the year.
- **Africa Fintech Funders-** an online portal for connecting Africa fintech startups with funders across the globe.

We invite all our partners to continue the good work with AFN as we systematically catalyze Africa's digital economic development.
